The Monitoring Team respectfully notifies the Court of the attached fourth quarter assessment into the Cleveland Division of Police ("CDP" or "the Division") use of force practices. This report is submitted in order to ensure that the intent of the specific reforms detailed in Paragraphs 46-83, 87-92, and 93-109 of the Consent Decree are met.¹

This assessment follows a preliminary review of use of force cases in which a select team of Monitoring Team members reviewed CDP use of force incidents that occurred between 2018 and 2019 to determine whether officers were applying force in a manner that complies with the Division's new policies and terms of the Consent Decree.

This quarterly report found that the uses of force reviewed were generally within policy, in most cases the chain of command reviews appropriately identified and addressed problematic uses of force by referring cases to Internal Affairs or the Training Section and supervisors on

scene engaged with officers in accordance with enumerated procedures. Still, the Monitoring

Team's preliminary review revealed several deficiencies in tactics and the ability to deescalate,

both of which at times created the need for more force. Further, the Monitoring Team concluded

that the Division needed to create processes and structures for issues identified during use of

force events, such as inadequate de-escalation or problematic tactics, to be addressed in training.

The Monitoring Team was also concerned by the duration of the use of force reviews by

the chain of command, which took several months. In the time since the review was conducted

and filed, Police 2.01.06, which dictates that "each level in the chain of command shall review

the [use of force] report within three tours of duty" was enacted.

The attached assessment ("Exhibit A") contains the Monitoring Team's assessment

methodology, results, a detailed background of select cases, and the Monitoring Team's

conclusions for this quarterly review.
